ITEM 4 - OTHER BUSINESS ACTIVITIES

Michael Koch is a Registered Representative and Investment Advisor Representative of LPL Financial, a securities broker/dealer, and a member of the Financial Industry Regulatory Authority, Inc. ("FINRA") and an investment adviser registered with the U.S Securities and Exchange Commission ("SEC").

As a broker-dealer, LPL engages in a broad range of activities normally associated with securities brokerage firms. Pursuant to the investment advice given by Michael Koch, investments in securities will be recommended for you. If LPL is selected as the broker-dealer, it will affect transactions in securities for you, a client of Fortis and Michael Koch. By serving as the broker-dealer, LPL and Michael Koch will receive commissions for executing securities transactions.

You are advised that if LPL is selected as the broker-dealer, the transaction charges may be higher or lower than the charges you may pay if the transactions were executed at other broker-dealers. You should note, however, that you are under no obligation to purchase securities through Michael Koch, Fortis or LPL.

Michael Koch will provide advice regarding investment company securities. You should be aware that, in addition to the advisory fees paid by you, each investment company also charges its own separate investment advisory fees and other expenses (internal management fees). In addition, you should be aware that mutual funds may be purchased separately independent of the investment management services of Fortis.

Michael Koch, in his capacity as registered representatives of LPL, or as agents appointed with various life, disability or other insurance companies, receives commissions, 12(b) -1 fees, trails, or other compensation from the respective product sponsors and/or as a result of effecting securities transactions for you. However, you should note that you are under no obligation to purchase any investment products through Michael Koch. He/she is able to offer a variety of advisory programs and services through LPL in addition to the advisory services he/she is able to offer through Fortis.

Michael Koch is an insurance agent through various agencies and carriers. It is anticipated that a small portion, less than (5%) of his time, will be spent providing these insurance products. In such capacity, he offers fixed insurance products and receive normal and customary commissions as a result of any purchases made by clients. The client is under no obligation to purchase fixed insurance through Michael Koch on a commissionable basis. In addition, Michael Koch receives other compensation such as fixed or variable life trails. The potential for receipt of commissions and other compensation gives him incentive to recommend insurance products based on the compensation received, rather than on the client's needs. To address this, disclosure is made to the client at the time purchase is made, identifying the nature of the transaction or relationship, the role to be played and any compensation (e.g., commissions, trails) to be paid by the client and/or received by the insurance agent.

In addition to serving as your investment advisory representative, Michael Koch is involved with Martin Financial Group. Time spent on these activities represents less than 1% of his time.

Michael Koch does business as MGK Wealth Management, LLC to market the services he provides.

ITEM 6 - SUPERVISION

Michael Koch is supervised through a compliance program designed to prevent and detect violations of the federal and state securities laws. Austin Sweerus reviews those policies and procedures annually for their adequacy and the effectiveness of their implementation. All policies and procedures of the firm are followed.
